**Report of the trustees (incorporating the director's report)**  
**For the year ended 31st March 2021**

The Trustees present their report and financial statements for the year ended 31st March 2020. The trustees who are also directors of The Architecture Foundation for the purposes of company law and who served during the year and up to the date of this report are set out in page 1.

**Structure, governance and management**

The Company is registered as a charitable company limited by guarantee and was set up by a Memorandum of Association on 30 October 1991. In 2012, a comprehensive review of governance was undertaken, resulting in a newly ratified Memorandum and Articles of Association in November 2012, which are fully compliant with current charity and companies law.

The management of the Company is the responsibility of the Trustees who are elected and co-opted under the terms of the Articles of Association. Day-to-day running of the organisation is delegated to the Director.

The Architecture Foundation's policy regarding the appointment and retirement of the Trustees is laid out in full within our Articles of Association, on file with the Companies House. Newly appointed Trustees receive in person briefings with the Chairman, Simon Allford, and an induction pack including the relevant forms to be submitted to Companies House, the Charity Commission and our internal files.

Changes within the structure, governance or infrastructure of the organisation that have had an effect on the activity in 2020-2021 include:

- Richard Ronald Jones, Holly Lewis and Paul Karakusevic retired as Trustees on 14 September 2020 and Professor Robert Mull retired on 10 November 2020.
- An open call for applications for new Trustees resulted in the appointment of Shumi Bose, David Ogunmuyiwa, Lesley Lokko and Adrian Lahoud on 8 March 2021.

**Objectives and activities**

Established in 1991 as the UK's first independent architecture centre, The Architecture Foundation has organised hundreds of design initiatives, events, exhibitions and education programmes in public venues across Britain and internationally. Until March 2015, The AF was an Arts Council England National Portfolio Organisation.

The AF's activities continue to be guided by its current mission statement:

*The Architecture Foundation seeks to expand the conversation about architecture and urbanism in London. It pursues this mission by:*

- *supporting the city's architects at the beginning of their careers*
- *providing a platform for the best architects from across the world to contribute to thinking about London's future*

Over 30 years after the fall of the Berlin Wall, divisive walls are being constructed all over the world – for example, along the US-Mexico border, and on the fragmented edges of 'Fortress Europe'. In the light of this context, James O'Leary, Associate Professor and Programme Director for the MA Situated Practice Programme at the Bartlett School of Architecture, examines the contentious pasts and possible futures of the Northern Ireland 'Peacewalls'. In 2013, the Office of the First Minister and deputy First Minister (OFMdFM) in Northern Ireland set a target of removing all 'Peacewalls' and interface barriers by 2023. Due to multiple factors both local and governmental, only limited progress has been achieved to date. Using material from the Peacewall Archive - a digital archive which aims to document the steady growth and hesitant removal of interface barriers in Belfast from 1969 to the present day - we will explore the 'peacelines' as a highly resilient system of division and control and further examine the polarising impact they continue to exert over their adjacent communities. In a resurgent era of conflict-related wall building, what can we learn from over 50 years of the infamous 'Peacewalls' in Belfast?

This devastating toll of urban decay reflects both the diversity of the district and the hardship of living in Marseille, a city marked for centuries by migration, poverty, and social struggle. Divided along ethnicity and class lines, with wealthy conservatives dominating the south and an energetic but pauperized community of immigrant origins in the north, Marseille highlights the tensions stemming from problematic governance, a lack of housing-stock maintenance, a constant influx of migrants, widespread privatization of services, and rapid, profit-driven, and destructive post-industrial urbanization. *Migrant Marseille: Architectures of Social Segregation and Urban Inclusivity* (Ruby Press, 2020) examines this complex city through the prism of the correlations between migration on space, architecture, and territory. In this conversation with the editors; Charlotte Malterre-Barthes, Assistant Professor of Urban Design at the Harvard Graduate School of Design, Marc Angélli, Professor Emeritus of Architecture & Design, ETH Zurich, and Leonard Streich, co-founder of Something Fantastic, they will discuss the role of planners in fostering tactics and strategies to support social and spatial integration.

Nature is vital to our very being. And yet, our current system continues to neglect it. And we continue to discount it in our conception of cities and the buildings that make up our cities. The volume, edited by Irene Cheng, Charles L. Davis II, Mabel O. Wilson, challenges us to write race back into architectural history and confront how racial thinking has intimately shaped some of the key concepts of modern architecture and culture over time, including freedom, revolution, character, national and indigenous style, progress, hybridity, climate, representation, and radicalism. In this discussion chaired by Michael Badu, and joined by Victoria Ogoegbunam Okoye, Shumi Bose, Mary Vaughan Johnson, Nana Biamah-Ofosu & Neal Shasore, we invite you to reflect on how architecture intersects with histories of slavery, colonialism, and inequality, and how the publication is situated within the UK's context.

## **Financial review 2020-21**

### **Summary**

For the second year in a row, the Architecture Foundation saw its underlying income decline by just over 20% in the financial year to 31 March 2021. After expenses, the result was a loss of -£10,504, another loss but materially better than the -£30,557 loss of the prior year.

### **Income and profit**

Underlying income for the period was -22% lower at £243.3 thousand (FY18-19: £291.5 thousand). As before, this excludes the contribution-in-kind for legal advice from Herbert Smith Freehills (offset by an equal expense) which amounted to £12,276 in the year.

The income for the year was severely impacted by the COVID-19 pandemic which all but erased important revenue streams related to our live activities (e.g. walking tours, talk tickets and book sales). Fortunately, we saw some progress in the income from supporters (up +10% YoY), members (up +88% YoY, due to the New Architects 4 book release) and donations. The supporter income remains the backbone of our charity and its importance only rose during this pandemic year, now making up 73% of our income (from around 50% in recent years). The supporter income remains broadly in line with our fixed salary cost. Since the end of the financial year, there are signs of recovery in our activity-related income and the foundation is also taking steps towards increasing commercial support/sponsorship income.

On the cost side, the total underlying expenses for the period declined by -26% to £241.6 thousand (FY16-17: £326.3 thousand), again excluding the non-cash cost for legal services from Herbert Smith Freehill. Compensation expenses were -12% lower at £146.6 thousand (prior year £168.6 thousand) and benefitted from the government's furlough scheme. Nonetheless, these increased to 64% of the underlying income (FY18-19: 58%). Underlying non-compensation costs declined -41% to £81,7 thousand (from £138,3 thousand) as our activity-related costs (travel, fees, hotels, ...) evaporated with the decline in live events.

The cost-to-income ratio improved from 110% to 104%, resulting in a loss for the period of £-10.5 thousand (prior year: -£30.6 thousand profit).

#### Balance sheet and financial position

Total assets amounted to £185,1 thousand at 31 March 2021, including £106,0 thousand in cash balances and £79 thousand in accounts receivables. Net assets declined modestly from £131,2 thousand to £120,7 thousand.

Our cash balance at year end covers around 66% of our expected compensation cost for the following year (down from 83% at the end of the prior year).

#### Outlook

On the back of a partial recovery in our live activities, increased corporate sponsorship and a strong cash collection effort, the Architecture Foundation has been able to further strengthen on its cash balance. This positions us well for the future and even allows us to modestly expand the staff base, in order to accommodate a wider range of content. The foundation hopes to return to making a modest profit in the year 21-22.

#### Statement of Trustees' Responsibilities

The Trustees are responsible for preparing the Annual Report and the financial statements in accordance with applicable law and United Kingdom's Generally Accepted Accounting Practice.

Company and charity laws applicable to charities in England and Wales require the Trustees to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the Charity and of the surplus or deficit of the Charity in that period. In preparing those financial statements the Trustees have:

- selected suitable accounting policies and applied them consistently;
- observed the methods and principles in the Charities SORP;
- made judgements and estimates that are reasonable and prudent;
- stated whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepared the financial statements on a going concern basis (unless it is inappropriate to presume that the Charity will continue in operation). The Trustees have overall responsibility for ensuring that the Charity has an appropriate system of controls, financial and otherwise. They are also responsible for keeping proper accounting records that are sufficient to show and explain the Charity's transactions and disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the detection and prevention of fraud and other irregularities. The Trustees are responsible for the maintenance and integrity of the corporate and financial information included on the Company website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

#### Small company provisions


**Basis of independent examiner's statement**

**1. Accounting policies**

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and the preceding year.

**1.1. Statement of compliance**

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

**1.2. Incoming resources**

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of grants, donations and gifts and is included in full in the statement of financial activities when receivable. Grants where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.

Donated services and facilities are included at the value to the charity where this can be quantified. The value of services provided by volunteers has not been included.

Gifts donated for resale are included as incoming resources within activities for generating funds when they are sold.

Grants, including grants for the purchase of fixed assets, are recognised in full in the statement of financial activities in the year in which they are receivable.

**1.3. Resources expended**

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Costs of generating funds comprise the costs associated with attracting voluntary income and the costs of trading for fundraising purposes including the charity's shop.

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Support costs are those costs incurred directly in support of expenditure on the objects of the charity and include project management.

**1.4. Tangible fixed assets and depreciation**

Tangible fixed assets are stated at cost less accumulated depreciation. Depreciation is provided at rates calculated to write off the cost less residual value of each asset over its expected useful life, as follows:
