

## **KLCF Annual Report for Charity Commission for year to 31<sup>st</sup> March 2021**

During 2020/21, owing to government restrictions, there were periods of time when some of the activities mentioned below had to be cancelled or took place online via streaming and videoconferencing. We have streamed church meetings and sent out regular audio and video messages. We have ensured that those who are vulnerable or shielding have received support. Where church members had not previously had the means to access online resources, we provided the necessary equipment to all who needed it. We sent resources by post to families with children and also to those who could not access online resources. We made every effort to keep in touch with and support those who struggled with lockdowns and other restrictions. In particular, the lonely and vulnerable have been supported by socially-distanced visits, help with shopping and provision of resources to help them to stay connected.

We have continued to run regular Sunday services for members and non-members alike. These have incorporated praise and worship, prayer, preaching and teaching. Teaching for children has also been provided and there have been opportunities for social interaction and practical support.

We have run: regular meetings for prayer, pastoral support, encouragement, teaching and practical help; events for young people and teenagers; social and fun events for church members and others.

Our building has been offered to local voluntary, charitable and other groups for appropriate activities including Blood Donors and the Purfleet Trust. However, some of the groups who normally use our facilities have been unable to do so. We have supported Christians Against Poverty and Foodbank, providing facilities and funding to support people in severe financial need. We have also supported church members and attenders when in hospital.

We have supported financially a number of overseas partner churches and organisations with humanitarian aid and other practical support. We have also supported other churches and Christian organisations locally, regionally and nationally.

We have a Finance and Investment Policy, reviewed annually, which allows for the retention of reserves up to 200% of annual income in order to smooth out fluctuations in income and expenditure but also to purchase additional properties and/or make significant improvements to our existing properties. During this last year we have made significant upgrades and enhancements to the facilities in the church building. We are considering hiring or purchasing additional or alternative premises.

We are meeting our obligations to provide a pension scheme for employees.


