We received £550 from LCC for belonging to a collaboration which we purchased some new low level screens, a new book case on wheels and a screwdriver and spanner set. Unfortunately the coronavirus pandemic affected any further fundraising as we closed from 20th March to 1st June and were unable to hold any of our usual events such as Easter fun day, sports day and stalls at feres. We were also affected by parents not sending their children in who were not eligible for free funding once we reopened in June we still received our local authority funding and did not furlough staff
