. In addition to its typical nature of work in supporting the needy, the charity during this financial year involved in the following:

- 1- The campaign to raise funds to support orphans, widows and suffering families with little or no income in Iraq on regular basis has continued during this year. The number of orphans currently supported by this project exceeded 400 orphans.

- 4- Continuing to support the local community activities like Community Saturday School, Youth activities .
