

KING GEORGE'S FIELD, NORTH HOLMWOOD

Trustee's Annual Report for the year ended 31 March 2025.

The information given below was correct as at 31st March 2025.

(1) Reference and administration details:

- (a) The charity is known as King George's Field North Holmwood ("the Charity").
- (b) The Charity is registered with the Charity Commission, No. 305015.
- (c) The Charity trustee is Mole Valley District Council ("the Council") of Pippbrook, Dorking, Surrey RH4 1SJ, which is the principal address of the Charity.
- (d) The Council is a corporate body whose Chief Executive for the period up to 31/03/25 was Karen Brimacombe. A list of the current members of the Council is available on request.
- (e) The recreation ground is managed by Andrew Reeves, the Council's Parks and Landscape Manager.
- (f) The Charity's bankers are National Westminster Bank plc of 39 Station Road, Redhill, RH1 1QN.
- (g) Tom Penlington the Service Lead (Legal) and Solicitor to the Council, acts as solicitor to the Charity. Employees in the Council's Financial Services department acted as its accountant for the period up to 31/03/25. Bullimores LLP acted as the independent examiner of the Charity's accounts.

(2) Structure, governance and management:

- (a) The Charity comprises two areas of open space provided for public benefit for informal recreation and some organised amateur sports. The public are able to gain free access to the open spaces at all times.

The original Charity was established on 30th September 1950 by a Conveyance made between Howard Martineau and Dorking Urban District Council. By this document, which is the Charity's governing instrument, certain land was given to the Council and the Council covenanted to maintain part of that land and other land which it already owned as a playing field to be known at all times as King George's Field North Holmwood.

- (b) The Council is a corporate body, whose members are elected periodically by residents of the district in accordance with electoral law.

(c) No specialist policies and procedures are adopted for the induction and training of Council members as trustees. However, all members undergo induction training which covers the structure of the Council, how decisions are taken and the code of conduct. In addition the Member Development and Training Plan also includes training on Equality and Diversity, Risk Management, Finance and Audit. All staff at the Council attend Equality and Diversity and Safeguarding Children courses so that such matters are taken into consideration. Staff dealing with charity affairs are made aware of Charity Commission advice on the role of local authorities when acting as trustee.

(d) Issues of policy, long leases, and works of significant value are all put before the trustee through the Council's Executive. The Charity Commission's guidance on public benefit is taken into account when dealing with the management of the Charity.

(e) The major risks to which the charity is exposed have been reviewed and systems have been established to mitigate those risks.

(3) Financial Review:

(a) The Charity has no disposable reserves. The Charity's surplus expenditure was funded by the Council as part of its normal annual expenditure on parks and open spaces and the Charity's assets are held to fulfill the charitable objectives of the trust. The unrestricted funds cannot be spent as if they were income.

(b) The whole of the land owned by the Charity is permanent endowment.

(5) Objectives and Activities:

(a) In accordance with the the Charity's governing instrument the Council maintains the public open spaces as playing fields.

(b) The public benefit guidance provided by the Charity Commission is taken into account when dealing with the day to day management of the Charity.

(c) (i) The original Charity land comprised a public open space off Deepdene Avenue, North Holmwood. It is maintained largely as a regularly mown grass field with an area of woodland along one side. In addition, there is a fenced children's play area and one mini and one full-sized football pitch which were both used regularly this year by a local youth football team for organised amateur sports. There is a concrete skate-park and youth shelter adjacent to the play area on the West of the site which was designed by and is well used by local young people. A new footbridge was installed across the adjacent brook and new footpaths were constructed to provide improved access to the skate park and play area. There is also a new pavilion on the site.

(ii) In August 2008 the Charity acquired a further area of public open space at Chart Downs, North Holmwood. This area is laid out as public open space and includes a children's playground and multi use games area located at the eastern end of the land. Between the playground and the community centre (which does not form part of the land held by the Charity) there is an informal football pitch. The site is surrounded by a housing estate, and is well used as an informal play area.

These facilities and the involvement of local groups help to promote community development, healthier lifestyles and amateur sports.

(6) Achievements and Performance:

As in previous years, both of the areas have continued to be actively used by members of the public and the various groups referred to above. The Trustees' continued maintenance of these fields as public open space and recreational areas has assisted with the promotion of amateur sports, healthier lifestyles and community development.

The Football Development Plan for the site is proving effective with increased participation in both boys and girls football. A Friends of King George V Playing Group was established in August 2011 which, overseen by the Council, runs a voluntary café from the pavilion and open the pavilion toilets for public use. The proceeds from the café are used to fund events and activities on the site organized by the group and this is increasing use of the site.

(7) Plans for future Periods:

Looking to the future, it is anticipated that these two areas will continue to be retained as public open spaces and be maintained for the benefit of local residents and the public at large.

The Parks team are exploring ways in which the biodiversity of the site can be improved through planting and amending the current management.
