Receipts during the year amounted to £28,458 (2023: £28,001) and the money expended during the year amounted to £26,124 (2023: £26,414).

This resulted in a surplus for the year of £2,334 (2023: £1,587)

Funds carried forward at the end of the year amounted to £19,646 (2023: £6,302)
