Annual Report for the year ended 31 December 2020



The Charity is administered by the three trustees, Messrs G S Morris, S B Benaim and R M Benaim.

The object of the Charity is to provide support for a Talmudical College known as Nahalat Moshe in Jerusalem, Israel and promote the Orthodox Jewish Religion and religious education and also to provide support for indigent students of the college.

The Charity employs no staff.

The Charity raised £127,181 from well-wishers during the year and made grants to the college of £119,378. The balance held at the bank at the year-end of £24,999 was transferred to the college after the end of the year.


