STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

Word of Life is a charity registered on 22 January 1990. The charity was established under a constitution dated 8 December 1989.

Recruitment and appointment of trustees

Under the requirements of the Constitution, the trustees are elected at the Annual General Meeting. All trustees are members of the charity.

In 2024 Word of Life welcomed Abdul Mustapha onto the Board.

Trustee induction and training

All trustees are familiar with the practical work of the charity and are encouraged to be involved with the on-going work of the charity. They actively engage with its activities and are familiar with the context within which it operates, including:

- The obligations of trustees
- The main documents which set out the operational framework for the charity including the Constitution
- Resourcing and the current financial position
- Future plans and objectives

Organisational structure

The trustees meet at least four times a year (quarterly) and are responsible for the strategic direction and policy of the charity. At the end of 2024 there are six trustees from a variety of backgrounds all relevant to the work of the charity.

A scheme of delegation is in place. Following his 2023 release to focus on curriculum development, this year the Director (Tim Green) maintained this role, with day to day responsibility for the charity with the Associate Director (David Watson). The Chair and Treasurer continue working closely with the Associate Director; the Administrator (Lindsey Stephenson); and several Track Leaders, some who are employed by the charity (Jennifer Fenton, Valentina Ten) and others on a seconded basis (Pat Brittenden, Helen Lee).

The leadership team and Administrator work closely with groups of staff and volunteers on a regular basis, within the different projects of the charity. In 2024 we developed new roles with regional focuses (Africa and S E Asia) to develop our networks there, and recruited new team members into the main tracks.

Financial review

With the aid and support of supporters, volunteers and grants, the Charity raised £325,556 (2023: £96,147) for the year, of which £267,643 was restricted for particular projects. Gift Aid was applied for regularly.

The Charity's expenditure during 2024 financial year was £201,578 (2023: £111,313). This was spent on the development of our projects, salaries, governance, and administration overheads, and included £169,551 of restricted funds.

The net movement for the year was £123,978 (2023: -£15,166).

Both income and expenditure increased compared to 2023. In 2024, we received several significant grants comprising restricted funds designated for project work scheduled for completion in 2025 and 2026. A portion of this funding was strategically invested in expanding our team and enhancing our infrastructure, including the development of a new database and the implementation of translation software. We also convened gatherings to establish a robust research foundation for new course development, followed by in-person meetings of course writers to accelerate progress through collaborative work.

As of 31 December 2024, the Charity held assets as cash in bank of £199,729 (31 December 2023: £75,751) which consisted of £109,127 restricted project funds and £90,602 unrestricted funds.

The trustees intend to continue to support the charity's projects, working in development of resources, training, and research in the following financial year.

Principal funding sources

Funding sources are primarily grants and gifts from supporters. In addition, in 2024 some income was received from sales of books.

Investment Policy

All the charity's funds are to be applied in the short term and no funds are held for long term investment. Some are in a current account and others are in a higher rate savings account. In 2025 the trustees will investigate transferring the reserves (see below) into a higher interest account, but still with instant access should they be needed.

Reserves Policy

Word of Life holds a reserve in its bank account which will allow it to operate for a three-month period in the event of future financial difficulty. The Reserves Policy was revised in 2021 and is regularly checked by the Associate Director and Treasurer. As of 31 December 2024, the charity held free reserves of £90,602 (31 December 2023: £64,716). The trustees are confident that the current reserves position will allow the charity to continue operating its current activities over the next financial year.

Plans for future periods

The charity will continue to seek for grants and support through donations, in order to advance the Christian faith in accordance with its objects.

Responsibilities of the trustees

Charity Law requires the trustees to prepare financial statements for each financial period which give a true and fair view of the state of the affairs of the charity as at the balance sheet date and of its income resources and application of resources, including income and expenditure, for the financial period. In preparing those financial statements, the trustees follow best practice and:

- select suitable accounting policies and then apply them consistently
- make judgements and estimates that are reasonable and prudent
- prepare the financial statements on the going concern basis, unless it is not appropriate to assume that the charity will continue that basis.

The trustees are responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with Charity Law.

The trustees are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

OUR AIMS AND OBJECTIVES

Purpose and aims

The charity's purposes, as set out in the objects in the Constitution, are the advancement of the Christian faith in such ways as the charity trustees may from time to time decide.

The trustees do not consider that any detriment or harm would arise from this charity's charitable purposes.

Ensuring work delivers our aims

We review our aims, objectives and activities annually. This review considers what has been achieved over the previous year, and how the charity has fulfilled its aims, while reflecting on the challenges and any disappointments. It helps the trustees to ensure that our aims, objectives and activities remain focussed on our stated purposes. This review also sets vision and targets for the following year, with reference to the guidance contained in the Charity Commission's general guidance on public benefit.

The focus of our work


Our main objective for the period was to advance the Christian faith.





