Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	<p>The needs for the religious instructions and supplementary education for the children is carried out five days a week, together with learning the Holy Quran in its original Arabic script. We teach the Fiqh (Islamic Jurisprudence) in English and other mother tongue languages. To this end we have employed ten teachers who are fluent in a number of languages reflecting the needs of our community.</p> <p>The trustees also manage the site of the old mosque at 479 Leeds Road. The three storey extension to the original building has been operational for some time now, hosting classes for the religious education for the girls, a much-needed requirement of the community which had been demanded for a long time. The original site is used for the teaching of religious education and Quran classes for the boys. This site had undergone a major renovation and refurbishment to bring all the facilities in the building up to date.</p> <p>The mosque has continued to conduct marriage and funeral prayers service free of charge for the convenience of the community. All marriages are solemnised under the Islamic Shariah, only once they have been registered at the Registrar's office.</p>
