There is no potential for harm as we are solely providing information that is general. No medical advice is given. Women and people with PCOS are the main beneficiaries but the public at large will also benefit by understanding more about PCOS through our work. These activities increase understanding and awareness of the condition which can help people get earlier diagnosis/treatment and can also reduce stigma.
