Objectives and activities of the charity

The RB Cameron Foundation is a grant making foundation set up to support other organisations and causes which have been found eligible in accordance with the charitable objectives of the charity, namely:

- The prevention or relief of poverty
- The advancement of education
- The advancement of religion
- The relief of those in need by reason of youth, age, ill-health, disability, financial hardship, or other disadvantage.

Achievements and performance of the charity

There are no achievements to report to date, other than the registration of the Foundation and progress in the setting up of a bank account.

Public benefit statement

The trustees have had regard to the Charity Commission for Northern Ireland's guidance on public benefit. There are no tangible benefits to date other than the establishment of the Foundation but that in itself is a start.

Financial Review

The financial results are as set out on pages 4-7 of the accounts. There has been no activity since the charity has been set up in May 2022. There is expected to be income and expenditure once the bank account is set up which is expected to be within the next year.
