### Introduction to the Annual Report

The Trustees of Friends of the Wumenu Community Farm (FWCF) (“the Charity”) are pleased to present the annual report for the financial year ending 31 March 2025.

Friends of the Wumenu Community Farm is a fully constituted Scottish charity based in Glasgow. Its aims, governance, and operational policies are clearly defined in its formal constitution. The Charity is registered with the Office of the Scottish Charity Regulator (OSCR) and complies with the requirements applicable to small charities.

This report, along with the accompanying receipts and payments accounts, has been prepared in accordance with the legal and regulatory standards set by OSCR.

FWCF does not meet the criteria to be classified as a large charity under the current OSCR guidelines.

For the financial year 2024/25, the Charity recorded a gross income of £75,217. Of this amount, £72,000 represents ring-fenced funds held on behalf of its affiliated organisation, the Wumenu Community Farm. Additionally, £2,000 is in the form of a loan from the Wumenu Community Farm, which is registered in Ghana.

In accordance with the requirements for non-company charities with gross income under £250,000, the financial statements have been prepared on a receipts and payments basis.

During the financial year 2024/25, Friends of the Wumenu Community Farm did not undertake any new projects.

FWCF Annual Report 2024/25



No charitable activities were carried out during the 2023/24 financial year. As a result of inactivity, the charity's bank account was closed due to dormancy. However, a new account was open with Co-Operative Bank A/C:

To meet its financial obligations for the year, the charity received funding comprising a grant of £750 and a loan of £2,000 from its affiliated charity, Wumenu Community Farm (registered in Ghana). In the previous financial year, the charity did not receive any grant funding.

The charity has effectively keeping records of its activities, thanks to the commitment of our secretary.</p> <p>The charity also benefits from voluntary services form some community members.</p>
Trustee recruitment and appointment	<p>For the financial year 2024/25, the charity has not appointed any new trustee.</p> <p>The charity has not engaged on any project in the current period. It is aiming to implement better projects and programs in the near future that will benefit its members and the community.</p>

**Objectives and Activities**

Friends of the Wumenu Community Farm was established with a broad set of charitable aims focused on community development, cultural promotion, and the empowerment of minority and migrant communities in Scotland. The Charity's objectives are summarised as follows:

- To promote the welfare and interests of Africans and other migrant communities living in Scotland.
- To support minority ethnic children and disadvantaged families in overcoming social and economic barriers, enabling them to reach their full potential.
- To promote, preserve, and celebrate African culture and arts within Scottish society.

- To strengthen the capacity of target groups through the principles of self-help and community development.
- To encourage members and supporters of the Charity to realise their full potential and aspirations as active and engaged global citizens.

These objectives guide the Charity's long-term strategic vision and community engagement efforts.

## ACHIEVEMENTS AND PERFORMANCE

Charitable purposes	<p>The purpose of the charity activities is geared to achieving the core-aims and goals.</p> <p>The charity has successfully delivered the African Oral History in 2018/19. A project that helps create a written book that compile and save variety of African cultures regarding common cultural practices like wedding, foods, dresses, African proverbs, and stories.</p> <p>The charity also delightfully organised The Black History project before it suspended its activities. This was an event that was organised to enlighten our children and, remind all and sundry of Black history. It highlighted how far we came as a community. It helps highlight the challenges we still face and how as a community we can overcome those challenges.</p>
Summary of the main activities in relation to these objects	<p><b>Achievements and Performance</b></p> <p>During the financial year 2024/25, Friends of the Wumenu Community Farm did not organise or deliver any charitable activities or programmes. All planned activities remain on hold.</p> <p>The Charity received a grant of £750 to support essential fixed expenses, along with donations totalling £467 during the reporting period. However, the cessation of charitable activities continues, primarily due to the inability to secure and operationalise a suitable space for community engagement and service delivery.</p>
Summary of the main achievements of the charity during the financial period	<p>The Trustees remain committed to the Charity's objectives and are actively exploring viable options to re-establish activities in the future, pending the availability of appropriate resources and facilities.</p>

## FINANCIAL REVIEW

Brief statement of the charity's policy on reserves

The Charity did not keep any monies aside in the financial year 2024/25.

Details of any deficit

The charity had a loan of £2,000, a grant of £750, and donations amounting £467 these monies were used to fund its financial obligations.

In the current year, the charity continue to incur fixed cost in relation to three storage space where it keep its valuable stock of items.

Chief Amu paid for these storage spaces to an amount of £ 5463.63 (2024: £4,620) in the prior year.

No donated facilities or services was made in the financial year 2024/25.

## ANALYSIS OF RECEIPTS AND PAYMENTS

### DONATIONS AND GRANTS

We have received a grant amounting to £750 (2023/24: £Nil) was received as grants. This was due to the fact that the charity did not carry out on ant activities in the financial year 2024/25.

We had donations of £467 in this current period (2023/24: £NIL).

### RECEIPTS FROM FUNDRAISING ACTIVITIES

The charity received £Nil (2023/24: £Nil). The fund-raising took the form of market stall by volunteers, which did not go as planned.

### RING-FENCED FUNDS FROM WUMENU COMMUNITY FARM (Ghana)

**The Friends of Wumenu Community Farm**, a registered Scottish charity, received a total of **£74,000** from its sister charity, **Wumenu Community Farm**, which is registered in **Ghana**. The primary purpose of this funding was to purchase farm equipment for use by the Wumenu Community Farm.

As part of this arrangement, both charities agreed that **£2,000 (Two Thousand Pounds Sterling)** of the total amount would be treated as a **loan** to The Friends of Wumenu Community Farm. The loan was designated to support the charity's operating expenses.

The loan was used to support the financial obligations and charitable activities of the Borrower, Friends of the Wumenu Community Farm, in accordance with its constitution and charitable objectives

### HIRE OF FACILITIES

The charity used to hire out its facilities to raise funds. Hall Hire has ever been the biggest source of income for the charity. However, due to lack of facilities, we do not have this income flow for now.

In the reporting period 2024/25 the charity raised £NIL (2023/24: £NIL)

### PAYMENTS RELATING DIRECTLY TO CHARITABLE ACTIVITIES

The Charity Trustees have cancelled telephone and broadband contracts and did not incur any admirative cost for the financial year 2024/25.

However, we continue to incur storage cost of £5,608 (2023/24: £4,620) for three storage spaces.

Other financial obligations relating directly to charitable activities such as rent, expenses on volunteer and transport amounted to £ 1,249.


The charity van is no more road worthy.


The Microwave and TV will not be reusable.

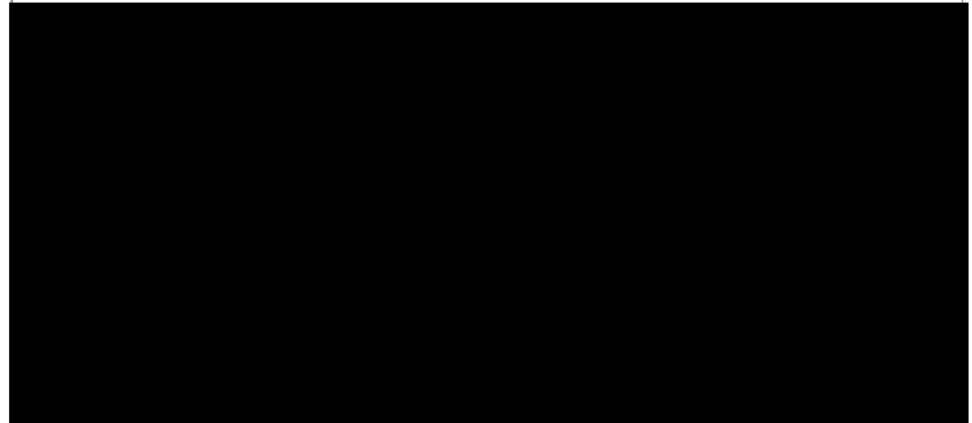
